  - The parking provided at 1800 S. Abilene Street is incorrect. Please correct it to 266 spaces as shown on the Colorado Community Church – Parking Lot cover sheet.

- Please note that all the landscaping shown on this sheet will have to be planted as shown in order to come into compliance. Per the Landscaping comment from David Barrett, any Ash or Russian Olive trees being replanted that are listed on this plan need to be shown as removed and replaced with a different species.
  - Please strike through all the Ash and Russian Olive trees listed on the Landscape Plan sheet. They should be replaced by another tree species listed on the plan or a new species.
- If Autumn Purple Ash, Marshall's Green Ash or Russian Olive trees exist currently on site, they do not need to be replaced. If the landscape plan indicates one of these three trees on site and it does not exist, the landscape plan must be amended to reflect a different tree species. Please let me know if you have any questions.
