Legal Description:

Part of a 26' Fire Lane & Utility Easement dedicated to the City of Aurora by The Chateaux at Aurora Park Subdivision Filing No. 1, a subdivision plat recorded in the offices of the Arapahoe County Clerk and Recorder in Plat Book 114 at Page 28, situated in the SW ¼ of Section 25, T.4S., R.67W., of the 6<sup>th</sup> P.M., Arapahoe County, Colorado, more particularly described as follows:

Thence N87°59'27"E a distance of 10.00 feet;

Thence S02°00'33"E a distance of 147.50 feet;

Thence S87°59'27"W a distance of 10.00 feet to the **Point of Beginning**.


