Hi Jacque,

Thanks for the note. In response to your question, the new transmission line will be built within Xcel existing 210-foot easement that was established in the 1960's. There is an existing transmission line on one side of the easement, the new line would be built parallel to that on the other side of the easement. The trees have simply grown in the easement in some of the riparian corridors and have not been removed by Xcel's veg management group since they are not large enough to be a danger to the existing T-line, but they would interfere with the new line.

Also, we were looking at doing a site visit in the next couple of weeks, and were wondering if you would be interested in attending.

As I mentioned in my message, Xcel is preparing to submit a site plan to the city for the new Pawnee to Daniels Park transmission line; however, there are several riparian areas within the easement that contain cottonwood trees which would likely need to be removed when the new project is constructed.

We would like to initiate the discussion with Forestry on the subject of tree removal within Xcel's right-of-way as part of this project, and what the city's policy is regarding removal of cottonwood trees.

If you would like, we would be happy to arrange a site visit with you to view the areas where tree removal may be needed.
