## Amendment to the Amended and Restated Road Maintenance Agreement

This amendment to the Amended and Restated Road Maintenance Agreement (“Amendment”) is between ConocoPhillips Company, a Delaware Corporation, and Burlington Resources Oil & Gas Company LP, a Delaware Limited Partnership, (“Operator”) and the City of Aurora, Colorado (“City”), a home rule municipal corporation of the State of Colorado located within Adams, Arapahoe, and Douglas Counties of Colorado. Operator and City may be referred to individually as “Party” or together as “Parties”. This Amendment is effective as of January 3, 2018 (“Effective Date”).

1. Operator and City entered into an Amended and Restated Road Maintenance Agreement Addressing ConocoPhillips Company and Burlington Resources Oil & Gas Company LP Oil and Gas Wells Within the City of Aurora (“Agreement”) effective January 3, 2018 with Reception No. D8002514 in Arapahoe County, CO and Reception No. 2018000002292 in Adams County, CO.
2. Operator and the City desire to update the Exhibit B of the Agreement to indicate the additional roads and wells to be included in the Agreement.

Now therefore, the Parties agree as follows,

1. In accordance with Article 2 of the Agreement, Exhibit B of the Agreement is to be deleted and replaced with the attached Exhibit B. The updated Exhibit B includes additional haul routes.

This Amendment may be signed in counterparts, each of which will be deemed an original and constitute one agreement.

This Amendment is signed as indicated in the acknowledgement but effective as of the Effective Date.


