The waivers associated with lot size and layouts shall comply with the standards outlined in the adopted version of the 2018-2019 Unified Development Ordinance. 3. Resolution of outstanding technical issues prior to the recordation of the Framework Development Plan. 4. The applicant shall continue to work with the City through the completion of the NEATS Refresh Study to ensure that 48th Avenue connects to Harvest Road.



The City Council hearing for the Comprehensive Plan Amendment, Rezoning Request and Framework Development Plan with Waivers is tentatively scheduled for October 8, 2018 at 7:30 pm for the introduction of the ordinances and public hearing for your cases. The "Notice of Public Hearing" letters to abutting property owners and HOA groups within a one mile radius must be sent out no later than Friday, September 28, 2018. The Notice of Public Hearing Signs shall also be posted at a point clearly visible from a public right-of-way by September 18.
