Thank you for your technical submission, which we started to process on May 14, 2020. We reviewed it and attached our comments along with this cover letter. The first section of our review highlights our major comments. The following sections contain more specific comments, including those received from other city departments and community members.

Since some issues still remain, you will need to make a second technical submission. Please revise your previous work and send us a new submission on or before June 9, 2020. I understand that you are working to finish the easement vacation process, and there are only a very limited number of comments regarding Life Safety and landscaping that should be easy to address. If desired, you can resubmit the drawings prior to June 9 for a quicker turnaround.

Note that all our comments are numbered. When you resubmit, include a cover letter specifically responding to each item. The Planning Department reserves the right to reject any resubmissions that fail to address these items. If you have made any other changes to your documents other than those requested, be sure to also specifically list them in your letter.

The Site Plan Amendment was approved by the Planning Commission at the April 8, 2020 meeting. Please remember that a condition of approval was the submission of an Operations Plan. Please advise as to the progress of the drafting of the plan, and whether you need assistance as to the contents of the plan.
