The city has developed CAD Data Submittal Standards for internal and external use to streamline the process of importing AutoCAD information into the city's Enterprise GIS. ***Please note that a digital submission meeting the CAD Data Submittal Standards is required before your final site plan mylars can be routed for signatures or recorded.*** Please review the [CAD Data Submittal Standards](#) and email your Case Manager the .DWG file before submitting your final site plan mylars. Once received, the city's AutoCAD Operator will run an audit report and your Case Manager will let you know within 2-3 days whether the .DWG file meets or does not meet the city's CAD Data Submittal Standards.

- Easement dedication by separate document is needed for the Utility Easement.
- Please label all easements and include sizes. See redline comments.

- Please update the site plan on Sheet 8 and 12 to show the new location of the trash enclosure and the new alignment of the sidewalk adjacent to the interior access drive.
- Please provide sheet numbers and sheet titles for the sign program sheets.
- Please update the west elevation on Sheet 13 as it has since been revised to provide spandrel glass treatments.
- Please complete the private easement with CenturyLink.
- Please remove all Copyright notes on the Sign Plan Sheets. This Site Plan is a public document subject to reproduction. Site Plans may not have any statements prohibiting their reproduction without written consent. An acceptable note would read, "The design is for the subject project and not to be used for other projects".
