1. Letter of Introduction

1A. Please incorporate a note about other uses within the building. This site was previously updated for retail use; please mention whether retail will be pursued and if any other current uses such as the church will continue and for how long.

2. Operations Plan

2A. Please identify the staffing and hours of use for the Colfax entry. This should include, *at minimum*, the hours of drop off and pick up as it corresponds directly with families walking to school, biking, or using the public transit stop at Colfax and Del Mar.

3. Site Plan

3A. The location of the bike racks should be reconsidered. Consider putting the bicycle racks outside of the Colfax entry or within the building directly adjacent to the Colfax entry. This will promote pedestrian use of the Colfax entry during those drop off and pick up times and will better meet the intent of the Colfax Main Street Overlay District. Staff will not support the bicycle racks in the rear as there are no pedestrian walks through this alley way to connect to the walks on Galena Street.

3B. Please add an additional two bike racks to meet the demand of the school at full capacity.

4. Completeness of Application

4A. Traffic study must be uploaded with the next submittal.

4B. Your Planning Commission Study Session is scheduled for Wednesday, January 24th, 2018. Please provide a copy via email of your presentation (required) to your case manager no later than Friday, January 19th. We recommend that you touch on the following topics: vision of the school, history of the school, operations and site access, circulation on site, and future growth. Your presentation may be in PowerPoint format and does not have any time limitations; we recommend staying between a 5-10 minute time frame.

Off-street parking is substandard for a school of +540 students plus faculty and visitors. This segment of Colfax accommodates RTD bus and limited 2-hr on-street parking within a zone of 25-30 mph posted speed. School hours and associated traffic (vehicles, foot and bicycle) would appear to align with current peak hour congestion that occurs daily on this segment of Colfax. Additional parking and loading along Colfax to serve the school could be problematic to efficient traffic movement.
