

Dear Ms. Godfrey:

This law firm represents RME Petroleum Company, formerly known as Union Pacific Resources Company, and RME Land Corp., formerly known as Union Pacific Land Resources Corporation, (together the "RME entities") with respect to the notice and waiver for Gateway Assets, LLC and Gateway Land, LLC (together the "Gateway entities") that you requested be signed by the RME entities.

This letter constitutes a waiver by the RME entities of their rights as owners of the mineral estate to receive notice of certain land use applications under Colorado Revised Statutes §§ 24-65.5-103, 30-28-133, and 31-23-215 ("Notice") under the terms and circumstances set forth in this letter as follows:

1. Notice is waived for applications for development as defined in C.R.S. § 24-65.5-102(2) that are filed by the Gateway entities with the City and County of Denver and the City of Aurora ("Applications"). The RME entities do not at this time intend to file an objection with respect to such Applications; and
2. Notice is waived only to the extent an Application includes the property ("Property") that is described in the attached Exhibits A, B, C and D ("Exhibits"); and
3. Notice is not waived to the extent an Application includes property for which the RME entities own minerals that is not described in the attached Exhibits; and

4. This waiver applies only to the mineral interests owned by the RME entities or either of them in the Property. It does not in any respect apply to mineral interests owned or claimed by any other person or entity in any of the Property, including any leasehold interests granted or assigned prior to the sale by either Union Pacific Land Resources Corporation or Upland Industrial Development Company, of all or any part of the Property.

The RME entities understand that the Gateway entities intend to provide this letter to the City and County of Denver and/or the City of Aurora in the context of an Application or Applications.
